

Meeting Minutes

- Bolting/Anchor Replacement/Liability - Drew Cziok
 - Crowley Fleck law firm representing us pro bono
 - Info from Dan and Andrew was beneficial and applicable
 - Negligence is primary issue we need to be aware of. Types: Duty, Breach of Duty, Causation, Damages.
 - Assumption of Risk - assuming risks inherent to the sport
 - Comparative negligence -
 - Clipping a bolt you know is not safe
 - Environmental rules to abide by - drilling in wilderness
 - Montana Recreation Responsibility Act
 - MT law regarding nonprofits - Individuals (Board Members or Volunteers) acting as part of Nonprofit cannot be held personally liable
 - BOLTING - Main issue: The person doing the bolting gets injured or causes injury to another due to negligence.
 - Make sure people bolting on behalf of HCC is knowledgeable, placing correct gear, safe.
 - Clinic?? Should look into liability more before hosting this
 - Don't pay people for their time. Reimburse for hardware. Subsidize for stainless hardware.



- We should not advertise that we maintain all hardware in the Helena area.
Direct people to badbolts.com?
- HOSTING EVENTS
 - Don't host clinics that are teaching safety or are instructional
 - Don't facilitate the event but instead spread the word about the event
 - HCC events vs Private events. Waivers make it more obvious that it is an organized HCC event.
- Announcements - make sure to make statements in public announcements about safety, liability, personal responsibility
